

Step 1 - Choose how to deploy

First choose which deployment tool to use and whether to install from the cloud or from a local source on your network.

Deploy from a local source with the Office Deployment Tool: Manage your deployment with the ODT, and download and deploy from a local source on your network.

Deploy from a local source with Configuration Manager: Manage your deployment with Configuration Manager, and download and deploy from distribution points on your network.

\* Microsoft 365 Reports in the admin center - SharePoint site usage

As a Microsoft 365 admin, the Reports dashboard shows you the activity overview across various products in your organization. It enables you to drill in to get more granular insight about the activities specific to each product. For example,

you can get a high-level view of the value you are getting from SharePoint in terms of the total number of files that users store in SharePoint sites, how many files are actively being used, and the storage consumed across all these sites.

Then, you can drill into the SharePoint site usage report to understand the trends and per site level details for all sites.

How to get to the SharePoint site usage report

In the admin center, go to the Reports > Usage page.

From the dashboard homepage, click on the View more button on the SharePoint card.
